#### Respected Madam,

I, Nitin Prabhune, Practising Company Secretary, has been appointed as scrutinizer by the Board of Directors of Kalyani Forge Limited ("the Company") CIN: L28910MH1979PLC020959 at its meeting held on Thursday, 30th May, 2024 for the purpose of scrutinizing the remote e-voting and e-voting conducted at the 45th Annual General Meeting ("AGM") pursuant to the provisions of Section 108 of the Companies Act, 2013 and Rule 20 & 21 of the Companies (Management and Administration) Rules, 2014, as amended, read with General Circular No. 14/2020 dated 8th April, 2020, General Circular No. 17 /2020 dated 13th April, 2020, General Circular No. 20/2020 dated 5th May, 2020 and along with subsequent circulars issued in this regard, the latest being Circular No. 09/2023 dated 25th September, 2023 issued by the Ministry of Corporate Affairs (collectively referred to as 'MCA Circulars'), read with circulars issued by the SEBI having reference No. SEBI/HO/CFD/PoD-2/P/CIR/2023/4 dated 05th January, 2023 and the latest being Circular No. SEBI/HO/CFD/CFD-PoD-2/P/CIR/2023/167 dated 07th October, 2023 (collectively referred to as "MCA and SEBI Circulars" respectively) have permitted the holding of the Annual General Meeting through Video Conferencing ("VC") or Other Audio -Visual Means ("OAVM"), without the physical presence of the members at a common venue.

The Circulars inter-alia provide for relaxation in the manner in which the AGM to be held including the manner of sending the Notices and Annual Reports to the members and the manner of voting at the meeting. Further, pursuant to these Circulars physical attendance of members has been dispensed with and accordingly the facility for appointment of proxies by the members is also dispensed with. Members who attended the meeting through VC or OAVM were counted for the purpose of reckoning the quorum under section 103 of the Companies Act, 2013.

I submit herewith my report with respect to the resolutions proposed at the 45<sup>th</sup> AGM of the members of the Company:

### 1. Responsibility of the Management and the Scrutinizer:

The compliance with the provisions of the Companies Act, 2013 and the rules made thereunder read along with the MCA and SEBI Circulars as mentioned above and SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 relating to remote evoting and e-voting during the meeting by the members on the resolutions proposed in the Notice of the 45<sup>th</sup>AGM of the Company is the responsibility of the management. My responsibility as a Scrutinizer is to scrutinize the votes cast by remote e-voting and the e-voting conducted at the meeting held through VC/OAVM in a fair and transparent manner and render consolidated scrutinizer's report of the total votes cast in favour or against if any, to the Chairperson, on the resolutions, based on the reports generated from the electronic voting system provided by Link Intime India Private Limited. The Chairperson or the person authorised by her in writing shall declare results of the voting forthwith.

#### 2. Notice of AGM, advertisement and remote e-voting period:

In accordance with the notice of the 45<sup>th</sup> AGM sent to the members by way of email on 05<sup>th</sup> September, 2024, and uploaded on the website of the Company: <a href="https://www.kalyaniforge.co.in/">https://www.kalyaniforge.co.in/</a> and the 'Advertisement' published pursuant to Rule 20(4)(v) of the Companies(Management and Administration) Rules, 2014 as amended from time to time and the Circulars mentioned above on 06<sup>th</sup> September, 2024, the remote evoting period remained open from Tuesday, 24<sup>th</sup> September, 2024 (9.00 A.M.IST) to Thursday, 26<sup>th</sup> September, 2024 (5.00 P.M.IST).

#### 3. Cut-off Date:

The members holding shares as on the "cut off" date i.e. Friday, 20<sup>th</sup> September, 2024 were entitled to vote on the proposed resolutions (item nos. 1 to 5 as set out in the Notice of the 45<sup>th</sup>AGM of the Company.)

#### 4. Process of remote e-voting:

The remote e-voting system was blocked forthwith at the end of the remote e-voting period. The votes cast through remote e-voting system were unblocked on Friday, 27<sup>th</sup>

September, 2024 at around 11.49 A.M. after conclusion of the AGM in the presence of two witnesses who are not in the employment of the Company.

Thereafter, the details containing inter-alia, list of members who voted "for" and "against", were downloaded from the e-voting website of Link Intime India Private Limited. (https://instavote.linkintime.co.in/) and the same will be handed over to the authorized representative of the Chairperson.

#### 5. Process of voting at the AGM:

After declaration of commencement of e-voting during the conduct of the AGM, the members who had not voted through the remote e-voting process were instructed to cast their vote on the e-voting platform provided by Link Intime India Private Limited. (https:///instavote.linkintime.co.in/) Thereafter, the details containing inter-alia, list of members who voted "for" and "against" were downloaded from the e-voting platform provided by Link Intime India Private Limited.
